PARTICIPANT AGREEMENT, RELEASE AND ACKNOWLEDGEMENT OF RISK

In consideration of my minor child(ren) (or me, if not a minor) being allowed to participate in youth baseball using borrowed playing/practice fields and the services and equipment of The Scottsdale Fire and its agents, owners, officers, directors, volunteers, other participants, employees and all other persons acting in any capacity on its behalf (collectively, "The Scottsdale Fire"), I/we hereby agree to release, indemnify and discharge The Scottsdale Fire as follows. Whenever "I," "we," "us," "my," or "myself" is used, and participant is a minor, it refers to the undersigned parent or guardian for himself or herself, and on behalf of my child's other parent, my child or children, and my and their heirs, assigns, estate and personal representative. If participate is not a minor, it refers to undersigned and spouse (if applicable).

1. Acknowledgement that baseball play, practice and presence on the field has known and unanticipated risks, which can result in minor or serious physical or emotional injury, damage or even death ("injury") to my child(ren), to me, to property or third parties. I understand that such risks simply cannot be eliminated in a sport of this nature without taking away the essential qualities of the sport.

2. Agreement and promise to accept all, and be solely response for, any risks or injury existing in this sport, whether to or by participants or those who are guests of or viewing the participants. This agreement includes any activities connected to participation in the sport, including but not limited to travel to or from play or practice of the sport or from third parties on the playing field, and whether or not such activities are supplied, demanded or recommended by The Scottsdale Fire (collectively with the first sentence, all such activities include "participation" or "participating"). I agree to let my child(ren), or to, participate voluntarily in spite of the risks.

3. Release, discharge and indemnification of The Scottsdale Fire and the playing field owner for any claims, demands, injuries, damages or actions of whatever nature, whether arising in the past, now or in the future, whether known or unknown, arising due to injury to a participant or his guests, or to injury or loss of property arising out of or in connection with the use by participant or his guests of, or from presence upon or the services, facilitates and premises of the playing field. This hold harmless clause is meant to be interpreted its most comprehensive sense and includes (but not by way of limitation) any and all claims for personal injuries arising out of the negligence, or any actions or omissions, of The Scottsdale Fire.

4. Further agreement to indemnify The Scottsdale Fire or anyone acting on its behalf should they be required to incur attorneys' fees and costs to defend or enforce this Agreement.

5. Certification that I have adequate insurance to cover any injury or damage my child(ren) or me may cause or suffer while participating, or I agree to bear the costs of such injury or damage myself.

6. Certification that neither I nor my child(ren) have any medical or physical condition which could interfere with or risk safety in participating, or else I assume – and bear the costs of – all risks created directly or indirectly by such condition. The Scottsdale Fire strongly recommend that participants obtain a doctor's approval before participating.

7. Agreement to the application of Arizona law irrespective of its choice of law provisions and to the exclusive jurisdiction of Arizona courts in Maricopa County. If any provision of this Agreement is held invalid or unenforceable, such provisions shall be reduced or otherwise modified to the minimum extent necessary to make it valid and enforceable. If such provision cannot be so modified, it shall be severed and the remaining provisions of this Agreement shall be interpreted in such a way as to give maximum validity and enforceability to this Agreement. The remaining provisions hereof shall continue in full force and effect.

By signing this document, I acknowledge that if participant is hurt, I may be found by a court to have waived my rights to maintain a lawsuit against The Scottsdale Fire for any claim from which I released them herein.

I have had sufficient opportunity to read this entire document. I understand it and agree to be bound by all of its terms.
